I, the undersigned hereby assure the Institute authorities and as a student of the Institute I undertake -

- 1. to stay at Vallabh Vidyanagar during my study.
- 2. to undergo medical checkup after my admission.
- 3. to attend regularly (a) lectures (b) tutorials (c) practicals (d) practice tests (e) orientation programmes (f) guest lectures (g) all other extra-curricular activities conducted by the Institute.
- 4. that the fees and charges once paid will not be refunded under any circumstances, even if
 - (a) I am provisionally admitted and fail to produce final eligibility certificate of Sardar Patel University / GTU.
 - (b) my terms are not granted by the University.
 - (c) admission is cancelled at my request or by the authorities.
- 5. that in the event of cancellation of my admission at my request or otherwise, only the caution money deposit will be refunded on surrendering all the original receipts. No photo copies will be accepted for the purpose.
- 6. Each student is granted admission taking into consideration that he/she will complete the respective degree programme. Hence, cancellation of admission on any ground and under any circumstances will be subject to approval of Chairman, Charutar Vidya Mandal. The student will be required to pay the fee for the whole degree programme even if admission is cancelled as mentioned above.
- 7. to take prior permission from the Director for the leave of absence from the Institute.
- 8. to submit the medical certificate issued by the Registered Medical Officer for the period for which I may be sick within ten days of the recovery, along with the letter from my parents and if possible telephonic confirmation from the parents/guardians to that effect.
- 9. to observe general discipline of the Institute and will not be a party to any misdemeanor in the Institute.
- 10. that use of Mobile phone is strictly prohibited at the institute and hostel.
- 11. that indulging in activity like ragging etc. will be considered as serious offence.
- 12. to refrain from using unfair means in all the examinations and I shall not be aiding or abetting in using unfair means in the examinations.
- 13. to carry my Identity Card in the Institute premises and produce it whenever any authorized Institute's / CVM's person asks for it, failing which I am liable for disciplinary action against me.
- 14. to submit certificate stating absence due to participation in sports or co-curricular activities within ten days of completion of the event.
- 15. that granting of leave of absence does not mean that I shall be absolved from completing required number of days of attendance in theory or practical for certification of the journal.

- 16. that taking private coaching is prohibited.
- 17. to inform immediately the change in my address and/or telephone number to the office.
